#### Reporting Year: 2024



All other basic scope 3 emissions (Waste, Upstream and Downstream transportation and Distribution) were deemed to not be material to our carbon footprint because they do not apply to Globe Locums Limited and the way in which we operate.

#### **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 600 tCO<sub>2</sub>e by 20**28**. This is a reduction of **31**%

# Carbon Reduction Projects

## **Completed Carbon Reduction Initiatives**

The following environmental management measures and projects have been completed or implemented since the 2020 baseline. The carbon emission reduction achieved by these schemes equate to **356.6** tCO<sub>2</sub>e, a **30.4**%ge reduction against the 2020 baseline and the measures will be in effect when performing the contract

We have developed Globe's Green Strategy which included initiatives across Energy, Waste Management and Transport/travel emissions.

We have:

- Moved to renewable energy sources for our office (Opus Renewable)
- Switched from desktop PCs to laptops, requiring circa 65% less power
- Implemented PRI motion sensor lighting, improving efficiency by circa 20-30%
- Introduced smart thermostats for improved monitoring and management of energy useage and to monitor the impact of energy efficiency commitments
- Brought in staff training in the waste hierarchy: Reduce, Reuse, Recycle
- Started a staff Cycle-to-Work scheme

In the future we hope to implement further measures such as:

- Operating a paper-free office;
- Expanding cycling training to the locum workforce to encourage greener travel to Trust site.
- Adapting to hybrid working for our staff
- We are currently in the process of obtaining ISO14001 accreditation, ensuring we have an effective Environmental Management System (EMS).
